2) Regulatory Compliance

The Supplier shall comply with all the applicable laws, regulations, and policies on supply of products and services that they make available to TCE, both in letter and in spirit, in all the territories in which it operates.

3) Bribery and Corruption

The Supplier shall not engage in any form of bribery or corruption and/or any illegal or immoral activities.

4) Human Rights

- a) The Supplier shall not employ child labour.
- b) The Supplier shall not use forced labour in any form.
- c) The Supplier shall not practice the policies which are against the Human Rights.

5) Gift and Hospitality

The Supplier shall neither receive nor offer or make, directly or indirectly any illegal payments, remunerations, gifts, donations, or comparable benefits that are intended or perceived, to obtain uncompetitive favours for the conduct of its business with TCE.

6) HEALTH AND SAFETY

The Supplier shall strive to provide a safe, healthy, and clean working environment for its employees which are compliant to the applicable legal norms and conditions.

7) **ENVIRONMENT**

The Supplier shall strive for environmental sustainability, particularly with regard to the emission of greenhouse gases, consumption of water and energy and the management of waste and hazardous materials. The Supplier shall endeavour to offset the effect of climate change in its activities.

8) CONFLICT OF INTEREST

The Supplier shall not engage into financial or any other relationship with TCE and/or its employee that creates any actual or potential conflict of interest for TCE. The Supplier understands that a conflict of interest arises when the personal interest of TCE employee is inconsistent with the responsibilities of his/her position as an employee of TCE.

All such conflicts must be promptly disclosed by the Supplier. Even the appearance of a conflict of interest can cause damages to TCE and Supplier and hence the same must be disclosed in advance to TCE management.

a) The Supplier shall represent TCE (including Tata Brand) only when the Supplier is duly authorised by TCE and with prior written permission of TCE.
